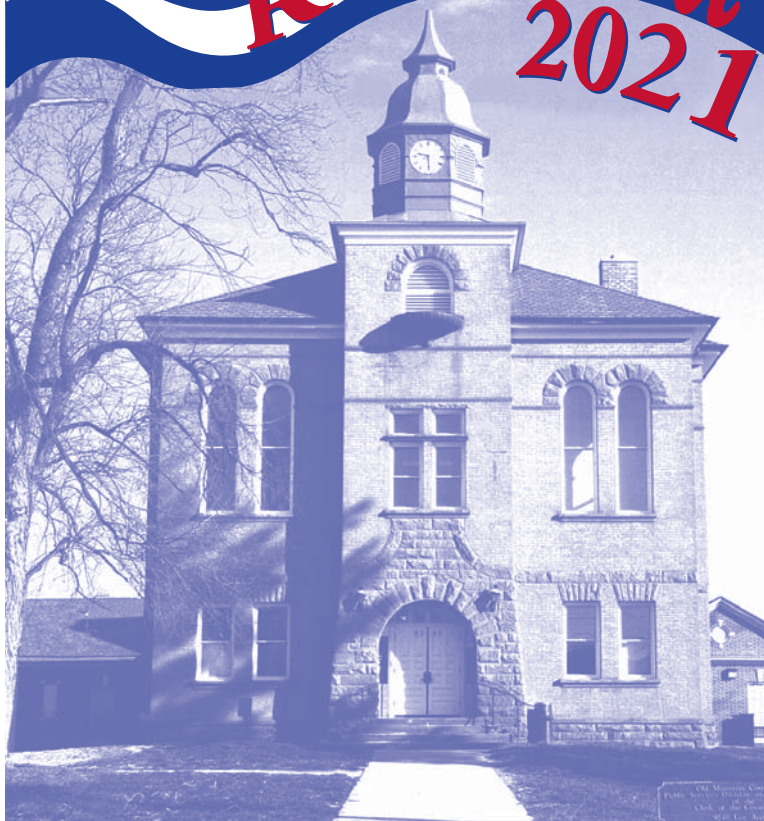

**Absentee Voting - New for November 2020**

Any registered voter may vote by absentee ballot.

By Mail: Application forms may be requested from one of the General Registrar Offices as listed below or downloaded from the jurisdiction's website. Mailed/faxed applications must be received in the General Registrar's office by 5 P.M. eleven (11) days prior to the election day.

In Person: Voting will be available 45 days (excluding Sundays) and up to and including the last Saturday prior to each election or as soon as ballots are received.
