League of Women Voters of Prince William-Fauquier Area President's Annual Report FY-2021-2022

The League completed its 15th Anniversary Year with a Crystal Cup full of robust activity and a membership that demonstratively made a difference in "Empowering Voters, Defending Democracy." Chartered by the LWVUS in 2007, the Legue expanded its footprint in 2021 when the LWVUS formally approved its Charter change request to include Fauquier County in the LWV Prince William Area League: League of Women Voters of Prince William-Fauquier Area (LWV-PWFA).

In the past fiscal year, the LWV-PWFA League revised and updated its Bylaws, redesigned the Website to make it more relevant and educational on *How the LWV works*. To better facilitate conducting Board duties and strengthening the Board interconnectivity realigned the Board positions, including adding new Board of Directors positions: Fauquier Unit Director, Membership Outreach Director, Meeting Co-Directors, Advocacy Director, Media Relations Director, Communications Director, and Event Registrar Coordination. In support of the expanded Board of Directors activities and programs, the League developed a highly successful unique SignUpGenius Volunteer Program: "Volunteer from Home."

The League co-hosted two virtual candidate fora (2nd and 31st House District) in Prince William County with the Committee of 100 Leaders, and one in-person candidate forum in Fauquier County (18th and 88th House District). Conducted Postcard campaigns. Collected and

submitted VOTE-411 information to the LWV-VA Data base. Distributed the *Top Ten* Palm cards and the *They Represent You* (TRY) post-election brochures at community events. The League participated in the Manassas Adult Detention Center (ADC) Felon Reentry Program Family Orientation with other Community Service Groups, distributing flyers and an information brochure.



The LWV-PWFA continued conducting its long-standing robust Voter Registration Program, in both Prince William and Fauquier County. As of April 30th, the League has 34 State Certified Voter Registration Members, who completed almost 1600 high school student registrations at 18 high schools, between July 1-April 30th. The LWV-PWFA League conducts its high school voter registration program in tandem with the Prince William

Bar Association "So You're 18" Program, and the Prince William Department of Elections' voter registration responsibilities. The League also completed 62 registrations at 16 Community Events, including all 12 Prince William Public Libraries on National Voter Registration Day.


The League reconstrued its Government Observer Corps Program and expanded its membership to strengthen the LWV-PWFA DNA footprint in the counties, including developing a Plan of Action to better identify local issues of interest and to propose advocacy actions on adopted League Public Policy positions.

The LVW-PWFA League focused on carrying out the League's Education and Advocacy Mission on the local level, by engaging speakers who expanded knowledge in support of adopted LWV-VA's Policy position (LWV-VA Position for Actions). A local government Environmental Call to Action was issued for: Virginia Disposable Plastic Bag Tax Law, and on the State level a Call to Action for the Virginia Assembly Budget Amendment Delaying the Ban on Polystyrene Containers. Wrote Letters to the Editor of "The Washington Post" and to the Board of Supervisors.

The League also organized two local Issue Study Committees, to review and develop a proposed LWV-PWFA Policy Position: 1) *Prince William County Racial and Social Justice Commission Report, and* 2) *Prince Williamm County Comprehensive Plan.* In addition, the LWV-PWFA has a volunteer on all four of the LWV-VA State Level Issue Study Committees: Child Care, Education Equity, Environmental Justice, and Money in Politics. Hosted two "Inside Our County Issues" Webinars: 1) Landfill *Plastic Disposal Challenges,* and 2) *Healthcare and the Price of Prescription Drugs*.

The League led a quarterly Book Discussion Group, hosted Sip and Civility events, and conducted member information workshops. The LWV-PWFA partnered with the Public Library to co-host a Book and Author Program: *Campaign for Women's Suffrage in Virginia*. Supported the *Delta Siga Theta Sorority Student Orators Contest*, by awarding the 6 finalists with books. The League publishes a bi-monthly Newsletter to keep the general membership informed, maintains a long-range Master Calendar, and issues periodic Constant Contact notices. The

LWV-PWFA members celebrated the League's 102 Birthday on February 14th with a quarter page color announcement in the local newspaper promoting League membership.

Why We Observe These Holidays

Memorial Day. Memorial Day is celebrated on Mat 30th. Did you know that although it comes at the end of a long carefree weekend for most of us, Memorial Day is not a celebration! It is meant to be a somber day. It originally was called Decoration Day and began after the Civil



War, which split the country in two as everyone was forced to take a side. Decoration Day provided an opportunity to start healing as a country by coming together and honoring those who had died. Over the years, Memorial Day has grown to include traditions such as the red poppy of remembrance, various parades and

ceremonies, and the National Moment of Remembrance.

Juneteenth. Although many Americans may not even be aware of it, Juneteenth recognizes a pivotal turning point in American history. The most popular celebration of Black emancipation in the United States after the Civil War, it commemorates June 19, 1865, the day Union General

Gordon Granger, accompanied by approximately 1,800 federal troops, arrived in Galveston, Texas, formerly part of the Confederate States of America, to take over the state and enforce Abraham Lincoln's Emancipation Proclamation from 1863. The name itself is, of course, a clever mash-up of the month and the date ("June" + "the nineteenth"). Today, 47 states and the District of Columbia acknowledge Juneteenth as



a state holiday or special day of observance, usually on the third Saturday in June.

Covid has been a significant challenge for our League, not only in terms of making us adapt to how we conduct our outreach and education to the community, but also in terms of our financial condition. We've continued to play a vital role in sponsoring debates, informing voters, and supporting democracy in action at the grassroots level, and we should be proud of our resilience and endurance!

Still, the costs of participating in these activities have continued unabated, while our membership has dropped, resulting in a decrease in dues payments. Even so, our League remains committed to voter outreach and education. We have plans to participate in many of the local community events over the next year, ready and eager to register voters and provide the most up-to-date information available on candidates running for office, logistical information on new voting districts, and any changes in election laws that may affect voters.

However, we are unable to do any of this without you – our League members. Your donations, whether they be of your time, talents, or financial resources, enable our mission to register and educate voters, empowering them to participate in the most basic right of our democracy, voting.

This June when you renew your membership in the LWV- PWFA Legue, we hope you will consider not just a regular membership (\$70) but increasing your contribution to the Champion of Suffrage level (\$100). If all our regular members do this, it will go a long way toward relieving the budget pressure we have.



LWV-VA Issue Study Selection. How Does the League Form "Positions"? What Is the League Program?

At-the LWV-VA State League level, a "position" is a statement of the League's point of view on an issue, arrived at through member study and agreement (consensus or concurrence), approved by Delegates to the Biennial Convention, and is the basis for League Advocacy action. The term League "Program" includes the entire process, from a Local League proposing an issue topic for study, through adoption of the proposed study by the Biennial Convention Delegates, to a proposed position reached by the Study Committee, and position adoption at the Biennial Convention. The identical Program development process is applied to form positions at the National, Regional, and Local League level.

There are four major steps in developing a position:

- § The League selects an issue to be studied at Convention or Council at state or by LLs at annual meetings.
- § The League studies the issue in a non-partisan, unbiased and objective manner.
- § Members come to an agreement about the issue using either the process of consensus or concurrence.
- § Based upon the result of the consensus or concurrence, a position statement is written, adopted by the respective League board, and subsequently approved by the League membership at an annual meeting or convention.

Year 1 through June 30, 2022

- § May/June, odd-numbered years, LWV-VA Convention adopts studies. (5/2021)
- § July (2021)—Study Committees get organized, begin research & share timeline, information, suggested activities, with local Leagues.
- § Local Leagues may have speakers, reading discussions, other activities to learn about the issues being studied.

Year 2 through June 30, 2023

- § July (2022)—Study Committees develop consensus questions; state board approves & disseminates to local Leagues.
- § Local Leagues plan their study consensus calendars to complete reports before the deadline.
- § August-February (2023)—Local Leagues continue learning, hold consensus meetings and report results at least 3 months before Convention. Local Leagues also review existing state positions and may propose new studies.
- § Study Committees & Program Director tabulate consensus reports, determine areas of consensus, draft positions & submit to state board.
- § Board adopts final position wording and shares with League members.
- § Positions are discussed and voted on at Convention (June 3-4, 2023).
