

## WHO CAN VOTE IN VIRGINIA?

Any U.S. Citizen who is a Virginia resident at least 18 years old (or will be 18 by the next general election, not currently declared mentally incompetent by a court of law, not convicted of a felony unless voting rights have been restored, not already registered and planning to vote in another state

Primary election June 20, 2023

General election November 7, 2023, Polls are open from 6:00 AM to 7:00 PM

## VOTER IDENTIFICATION

Acceptable identification when voting in person:

- VA Driver's license or ID card
- Military ID
- U.S. Passport
- Valid student ID
- Employee ID
- Other government issued ID
- College/University student ID from a Virginia institution

## REGISTER TO VOTE

(Deadline 22 days before election) You can register to vote in person, by mail, or online. After you submit your registration, you will receive a voter registration card in the mail.

Voters are now able to register and vote a provisional ballot on the same day if the voter registration deadline has passed. Voters should ask to complete a Same-Day Registration when they check in at an Early Voting site or Polling Place.
